UUSS Treasurer's Report - August 2024 August 22, 2024

This is the second report for the 2024-2025 fiscal year. As of August 31, our net income for the year was \$81,347, which is \$6,609 more than the \$74,738 budgeted.

A. FISCAL YEAR YEAR-TO-DATE NET INCOME

Our year-to-date revenue as of August 31 was \$207,067, which was 2% over the \$202,808 in the budget. Year-to-date expenses were expenses were \$125,720, 2% under the budgeted \$128,070.

Income items of interest:

- **a.** Our year-to-date pledges are \$4,275 over budget, including the \$9,312 in payments on last year's (2023-2024) pledges.
- **b.** No other anomalies were noted.

2. Expenditures items of interest:

- **a.** The large Minister Professional Expenses expenditures in July continue to cause those categories to exceed the year-to-date budget. The expenditures are within the amount budgeted for the year.
- **b.** Expenses in other categories were close to or under the amount budgeted.

B. August Highlights

- 1. August income exceeded the amount budgeted by \$5,449 (9.5%), predominately due to August pledge receipts exceeding budget. None of the pledge income in August was for last year's pledges.
- 2. Staff Compensation and Benefits, Administrative Expenses and Program Expenses were all significantly under budget in August, and all other categories were in line with the budget. No anomalies noted.

C. Cash Flow:

Cash flow (ability to pay bills) is not a concern currently, as the operating fund balance is \$302,309. The reserve ratio was 22% on August 31.

D. August 31, 2024, Balance Sheet (Total Assets: \$2,513,467)

- 1. Operating Fund (01): \$302,309. This includes the Reserve Fund, valued at \$116,568.
- **2.** *Temp. Restricted Fund (02):* \$450,773. This includes Bequests of \$340,946 and the Heritage Fund, at \$46,134.
- **3.** Endowment Trust (03): \$465,233. The Endowment Trust Loan (balance of \$259,976) is both an asset for the Endowment and a liability for UUSS.
- **4. Property and Equipment Fund (04):** \$1,295,152. This includes both the land and building (\$1,231,698) and the Capital Outlay Fund (\$62,546).

Endowment Trust loan: \$259,976. (1% interest-only loan; \$650/quarter, which is \$2,600 per year). The loan will come due in **June 2025**.
